Domestic Violence Advocate of the Year

These individuals and programs are comfortable working outside the box and have taken their role to a new level, using their passion and drive to make survivors' voices heard.

Community Partner of the Year

- The Community Partner of the Year Award recognizes those outside Nebraska's network of domestic violence/sexual assault programs who have shown a commitment to ending dating violence, domestic violence, sexual violence, and stalking through excellent service to survivors, partnership and collaboration with network programs, and/or the use of innovative outreach and prevention strategies.

- Nominees may include, but are not limited to, church or other community groups; allied professionals such as mental health practitioners, teachers, law enforcement

officers, child protection workers, or health care providers; and agencies or organizations such as law enforcement, schools, or human services.

Nominators will be informed by August 31, 2018 if their nominee was selected.

Awards will be presented on September 12, 2018, at a Backyard Bash celebration hosted by the Nebraska Coalition's Board of Directors.
